Jefferson County Commissioners Press Release: June 13, 2023 Strategic Management Program and Five Year Financial Plan

The Commissioners are pleased to accept this final report from Herbert, Rowland, and Grubic (HRG) on behalf of Jefferson County.

The Department of Community and Economic Development (DCED) under the local leadership of Terri Cunkle, Local Government Policy Specialist, made available the Strategic Management Program and Five Year Financial Plan by which our county was able to receive a solid review of our operations and potential funding to implement improvements.

We asked HRG in 2022 to examine our internal operations, policies, finances, personnel, physical space use, and programs. The intent of this effort is to determine the best and most effective use of the taxpayers' resources.

The Strategic Management Plan identified some good news, such as "...the Jefferson County Commissioners have done an excellent job managing the overall financial condition of the County..." however, we are looking for areas in need of improvement. The HRG Team developed 62 items for consideration that could enhance our operations, such as developing a Capital Improvement Plan, enhancing the County's use of technology, and updating the County's website to name a few.

We have already begun to take advantage of what we have learned from the draft report. Our HR policies are currently being revamped and we researched the best practices on the establishment of an Infrastructure Bank that could financially assist Jefferson County's thirty-four boroughs and townships.

Next, the Commissioners are looking to establish a Chief Financial Officer (CFO) position which will bring in-house expertise and reduce our reliance upon outside consultants, saving the County tens of thousands of dollars annually. We will also determine the feasibility of making more land, parcel, and property information available online. The report also suggests innovative approaches to tourism and economic development as well the more effective use of resources such as Hotel Tax revenue.

The implementation of this plan could bring the county up to \$1 million in grants through DCED. Due to the outstanding effort of our Community Development Director, Ben White, the County's match was reduced from 50% down to 10%, saving the taxpayers of Jefferson County hundreds of thousands of dollars.

The Commissioners of Jefferson County thank Mr. Grimm of HRG and Terri Cunkle of DCED for their efforts and diligence on behalf of our taxpayers. We look forward to cost savings and enhanced services for our citizens as a result of this hard work.




